LEGAL INSIGHTS



FORCE MAJEURE OR CHANGE OF CIRCUMSTANCES?

Recently, the authorities in key manufacturing hubs in the South of Vietnam, have issued orders requiring manufacturers to either create a production bubble or stop production until further notice. The question is now if these administrative orders from the local authorities should be considered as a force majeure event or a basic change of circumstances under Vietnamese law.



GOVERNMENTAL SUPPORT PACKAGES FOR EMPLOYERS AND EMPLOYEES

Resolution 68/NQ-CP of 1 July 2021 and Decision 23/2021/QD-TTg of 7 July 2021 introduce 12 support packages for employees and employers seriously affected by the COVID-19 pandemic. This update sets out the ones, enterprises might be most interested in. Qualification is subject to conditions set out in these documents.



VIETNAMESE E-COMMERCE STRUGGLES WITH LAWS AIMED AT TAXING ONLINE VENDORS

Referred to as "Circular 40", the new regulation moves to shift responsibility for vendors' tax liabilities from sales generated on online platforms to the respective platform operator.



DRAFT DECISION ON SPECIAL INVESTMENT INCENTIVES

To attract more foreign investment focusing on quality, efficiency, technology application, environment protection and that apply high technology, create added value, and connect global chains of production and supply a draft decision has been issued.

LAWS & REGULATIONS

Law No. 68/2020/QH14

The Residence Law provides for exercise of the right of Vietnamese citizens to reside in the Vietnam territory. The Law regulates the registration and management of permanent and temporary residence. In which, it has replaced the residence book with the detailed residence date recorded directly to the National Database on Residence. The Residence Law entered into force on 1 July 2021.

Decree No. 62/2021/ND-CP

This Decree sets out guidelines for the Residence Law. It prescribes the application dossier and procedures for removing the permanent/temporary residence registration, as well as make clear of function of the National Database of Residence. This Decree entered into force on 1 July 2021.

Decree No. 70/2021/NĐ-CP

This Decree amends the Decree No. 181/2013/ND-CP dated 14 November 2013 on elaboration of some articles of the Law on Advertising. Its scope focuses on cross-border advertisement service, such as: definition and interpretation, rights and obligations of advertising agencies, periodic reports regime. Decree 70 will enter into force on 15 September 2021.

Circular No. 32/2021/TT-BTC

This Circular provides instructions on the initial public offering of shares, management and use of proceeds from equitization involving transformation of State-Owned Enterprises and Single-Member Limited Liability Companies with 100% of their charter capital wholly held by State-Owned Enterprises into Joint-Stock Companies. It sets out detailed regulations on price of shares offering, methods of initial public offering of shares and matters relating to the proceeds from equitization of the State-Owned Enterprises. This benefits the management of the investors participating in a PPP project (e.g. solar power project).

Resolution 64/NQ-CP and Decision No. 23/2021/QD-TTg

This Resolution provides details and guides the procedures for applying to qualify for supporting policies for businesses and employees facing difficulties due to the impact of the pandemic. The Resolution and Decision are applicable as of 1 and 7 July 2021 respectively.
