TAX COMPLIANCE FOR ENTERPRISES HAVING RELATED-PARTY TRANSACTIONS

On 10 February 2025, the Government issued Decree No. 20/2025/ND-CP (“Decree 20”) amending Decree No. 132/2020/ND-CP dated 05 November 2020 guiding tax compliance for enterprises having related-party transactions. Decree 20 takes effect from 27 March 2025 and applies the tax year 2024.

LAWS & REGULATIONS

Decree No. 13/2025/ND-CP

Decree No. 13/2025/ND-CP ("**Decree 13**") was promulgated on 21 January 2025 and took effect on the same date, amending and supplementing specific provisions of Decree No. 115/2022/ND-CP dated 30 December 2022 ("**Decree 115**"). Decree 115 established Vietnam's Preferential Export Tariff Schedule and Special Preferential Import Tariff Schedule for implementing the Comprehensive and Progressive Agreement for Trans-Pacific Partnership ("**CPTPP**") for the period from 2022 to 2027. Decree 13 primarily addresses the accession of the United Kingdom of Great Britain and Northern Ireland to CPTPP.

Decree No. 19/2025/ND-CP

On 10 February 2025, Decree No. 19/2025/ND-CP ("**Decree 19**") was issued and took effect on the same date, providing detailed regulations on special investment procedures. Decree 19 elaborates on Article 36a of the Investment Law, as amended and supplemented in Law No. 57/2024/QH15, which introduces certain revisions to the Law on Planning, the Law on Investment, the Law on Public-Private Partnership Investment, and the Law on Bidding.

Circular No. 15/2024/TT-BLDTBXH

The Ministry of Labour, Invalids and Social Affairs issued Circular No. 15/2024/TT-BLDTBXH on 31 December 2024, repealing 10 legislative documents in the field of labour and wages that are no longer consistent with current regulations ("**Circular 15**"). Accordingly, Circular 15 fully repeals a total of 14 legislative documents, including 10 documents related to labour and wages and 4 documents related to social evils prevention, which took effect on 15 February 2025.

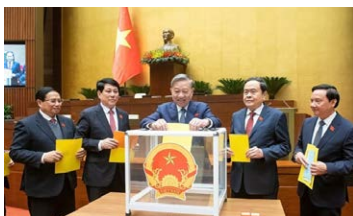
PM pushes for 8% growth investment acceleration

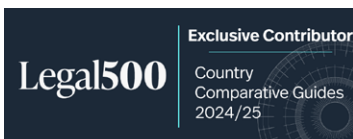
Vietnam approves carbon market development project

The project is designed to accelerate the development of a low-carbon economy and address climate change, working toward the goal of achieving net-zero emissions by 2050.
