IMPLEMENTATION OF TOP-UP CORPORATE INCOME TAX UNDER DECREE NO. 236/2025/ND-CP

On 29 August 2025, the Government of Vietnam issued Decree No. 236/2025/ND-CP ("Decree 236") to implement Resolution No. 107/2023/QH15 of the National Assembly dated 29 November 2023, concerning the application of top-up corporate income tax under the Global Anti-Base Erosion rules. Effective from 15 October 2025, Decree 236 is applicable for fiscal year 2024 onward.

Resolution No. 306/NQ-CP

The Government of Vietnam promulgated **Resolution No. 306/NQ-CP** on **5 October 2025**, approving adjustments to the National Master Plan for 2021–2030, with a vision to 2050, aiming for Vietnam to become a modern, upper-middle-income country by 2030. The Resolution defines six socio-economic regions and prioritizes innovation, digital transformation, green growth, and modern infrastructure.

Document No. 187/CD-TTg

Document No. 187/CD-TTg, promulgated on 4 October 2025, directs ministries and local authorities to strengthen the control and simplification of administrative procedures and business conditions. It sets a target to reduce at least 30% of time and costs for administrative procedures in 2025, ensure 100% of business-related procedures are available online and independent of administrative boundaries, and enhance transparency and coordination in implementation.

Document No. 9533/VPCP-CN

Document No. 9533/VPCP-CN, promulgated on 4 October 2025, directs the Ministry of Finance, in coordination with relevant ministries, to incorporate revisions to the draft amended Investment Law in line with the new Railway Law (No. 95/2025/QH15). The document emphasizes clarifying contract terms, investment incentives, and procedures for strategic infrastructure projects before submission to the National Assembly.


