#### GOVERNANCE, RISK MANAGEMENT, AND COMPLIANCE

#### Governance

is the combination of processes established and executed by the directors (or the board of directors) that are reflected in the organisation's structure and how it is managed and led toward achieving goals

#### Risk Management

is predicting and managing risks that could hinder the organisation from reliably achieving its objectives under uncertainty

#### Compliance

refers to adhering with the mandated boundaries (laws and regulations) and voluntary

#### GOVERNANCE, RISK MANAGEMENT, AND COMPLIANCE (CONTINUED)

- Governance, Risk Management, and Compliance (GRC) are 3 related facets that help assure an organisation reliably achieves objectives, addresses uncertainty and acts with integrity.
- GRC is a discipline that aims to synchronise information and activity across governance, risk management and compliance in order to operate more efficiently, enable effective information sharing, more effectively report activities and avoid wasteful overlaps.

#### **CRIMINAL LIABILITY FOR EMPLOYEES**

- Bribery / corruption;
- Trade in counterfeit products;
- Violate Law on Food Safety and Money laundering; Hygiene laws;
- Insider trading;
- Produce/trade in counterfeit products; Environmental emergency violation;
- Violate regulations of Law on 
  Terrorism financing; Accounting;
- Violate regulations of Law Occupational Safety, Occupational Hygiene and Safety;
- violation;

- Commit fraud in performance of duties;
- IPR infringement (copyright / industrial) property rights);

- Violate regulations on Law on Bidding;
- on Abuse of power or position to influence another person for personal gain; and
- Environmental pollution / emergency Reveal work secrets, appropriate, trade or destruct work secret documents.



#### CRIMINAL LIABILITY FOR LEGAL REPRESENTATIVE (ADDITIONAL)

- Employment (coercion / illegal termination);
- Anti-competitive behaviour; and
- Evasion of social, unemployment, and health insurance payment.





#### HOW TO BE COMPLIANT AS A BUSINESS BBGV

#### CRIMINAL LIABILITY FOR CORPORATE LEGAL ENTITIES (ART 76)

- Tax evasion;
- Environmental pollution;
- IPR infringement (copyright / industrial property rights);
- Insider trading;
- Publish false information or conceal information in securities activities;

- Insurance fraud;
- Social insurance payment evasion;
- Environmental emergency violation;
- Manufacture / trade of counterfeit foods, foodstuff or food additives;
- Anti-competitive behaviour; and
- Terrorist financing.



#### CRIMINAL LIABILITY FOR CORPORATE LEGAL ENTITIES (CONTINUED)

- Violations related to tax, competition, environment, business and trading which are not a criminal offence, can be *administratively* sanctioned. (art 2.1 Law on Handling Administrative Violations).
- There is no relevant provision dealing with the liability of directors or managers for not having adopted (intentionally or negligently) measures to prevent a crime. However, according to the Penal Code, any person could be criminal liable who
- conceals crimes; or
- knows that a crime is being prepared, being carried out, or has been carried out but fails to report (misprision, with some exceptions).

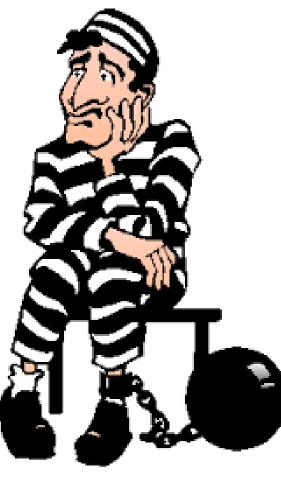

#### CRIMINAL LIABILITY FOR CORPORATE LEGAL ENTITIES (CONTINUED)

- Corporate legal entity bears criminal liability if
  - The criminal offence is committed in the name of the corporate legal entity; and
  - The criminal offence is committed in the interests of the corporate legal entity; and
  - The criminal offence is under instructions or approval of the corporate legal entity; and
  - The time limit for criminal prosecution has not yet expired.

The fact that corporate legal entity has criminal liability does not exempt criminal liability of individuals.

If a convicted corporate legal entity is divided, separated, consolidated or merged, the succeeding corporate legal entity inherits rights and duties from the convicted corporate legal entity and will be liable for any pecuniary penalties and damages. (art 445.3 Criminal Procedural Law)



#### ENTITIES COVERED (ART 19)

- The Penal Code applies to both foreign and Vietnamese corporate legal entities. "A commercial juridical person (or corporate legal entity) means a juridical person whose primary purpose is seeking profits and its profits shall be distributed to its members and include enterprises and other business entities." (art 75 Civil Code)
- In case the criminal offence is committed by
  - a *subsidiary*, the parent company will *not* be liable (as independent entity);
  - a *Representative Office or branch*, the parent company *could* be liable (as not independent legal entities).





#### **TERITORIES COVERED (ART 6)**

- Criminal offence committed on Vietnamese territory; and
- Criminal offence committed outside Vietnamese territory by
  - Vietnamese corporate legal entity and criminal offence is defined in the (Vietnamese) Penal Code shall face criminal prosecution in Vietnam; and
  - Foreign corporate legal entity if
    - the offence infringes the lawful rights and interests of Vietnamese citizens or interest of the Socialist Republic of Vietnam; or
    - under an international agreement to which Vietnam is a signatory.



# ACSV

#### HOW TO BE COMPLIANT AS A BUSINESS BBGV

#### PENALTIES

- Applicable penalties
  - Monetary fine;
  - Forced suspension or termination of business operations; or
  - Ban to conduct certain business activities and/or to raise capital.

#### Additional measures

- Judicial measures;
- Interim measures;
- Cease-and-desist order;
- Bans; or
- Confiscatory measures.

In case of aggravating circumstances punishments can be higher.

#### COMPLIANCE

- Use of internal information to deal in securities (art 210)
- Launder money (art 324)
- Bribery and abuse of power (art 354, 355, 356, 364, 365, 366)
  - Implement policy and appoint compliance officer; and
  - Include reference to policy in (depending on the person) in
    - internal labour rules; -
    - appendix labour contract; or
    - have every employee/relevant person in the company sign a document that he/she has read the policy and will comply with it.

Note that giving bribes (directly or via intermediary) to private officials is now also a criminal offence.

#### **COMPLIANCE** (CONTINUED)

Violate anti-competition regulations (art 217)

The competition law is being reviewed, the following is likely to fall under the scope of the Competition Law:

- Offshore activities having an impact on the Vietnamese market; and
- M&A deals between offshore entities and indirect equity interests in a Vietnam-based entity.
